**Starting Times:** Please call the Club - (248) 661-2300 - after 12:00 PM on Tuesday, June 21. **All players registering for the tournament MUST be available for play Thursday (12 pm – dark) and Friday-Sunday THROUGHOUT THE DAY (beginning as early as 9 a.m.). In any division of more than 16 players, two singles rounds might be scheduled on any particular day.**

**Tournament Format:**

- Each division is limited to 32 Singles players and 16 Doubles teams. All matches will be 2-out-of-3 sets. Twelve point tie break at six games all in all three sets. The point penalty system will be used with a 15 minute default time.
- There will be roving umpires.
- First Match Consolation (FMLC) for singles only.
- This tournament is a USTA Midwest Championship and will meet that qualification for a sectional ranking.
- **The rules of the Midwest Tennis Association state: If a player defaults a scheduled match in a tournament FOR ANY REASON (including scheduled consolations or playoffs), the tournament will not count toward meeting the minimum tournament requirements for ranking consideration.**
- USTA card must be presented to the Tournament Desk when registering.
- Depending on the size of the draw, consolation matches may be played indoors, and in case of rain may be canceled or go to an abbreviated format. A player may enter a maximum of one singles and one doubles event.
